Further to the Other Relevant Information published on February 17, 2026, following the meeting of the Board of Directors of Indexa Capital Group S.A., held on December 17, 2025, in which it resolved to establish a Share Buyback Program (the “Buyback Program”), pursuant to the authorization granted in its favor under resolution Sixth of the General Shareholders' Meeting held on May 17, 2023, for the derivative acquisition of the Company’s own shares, and to the extension of such authorization granted under resolution Eighth of the General Shareholders’ Meeting held on April 28, 2025, as well as in accordance with the provisions of Article 5 of the Regulation (EU) No 596/2014 on Market Abuse, and Articles 2.2 and 2.3 of Commission Delegated Regulation (EU) No 2016/1052 of March 8, 2016, the Company hereby reports that it has carried out the following transactions (based on the information provided by Renta 4 Banco, S.A. in its capacity as managing entity of the Buyback Program) during the period **from June 1 to June 5, 2026**.
